INFORMATION ON ENROLLMENT PROCESS FOR EU AND EQUATED CITIZENS:
Step 1: The enrollment application must be completed by logging the site www.uniweb.unipd.it with your own credentials no later than 12.00 noon the 26th October 2016. Home -Enrolment - Check List - Choose the degree course enrollment - Book the time and day in which to report to the Enrolment Office to finalize the registration; - Complete the questionnaires provided; - Confirm and print the enrollment application and the MAV form for the payment of the first installment of tuition fees, which amount is 568,50 Euros. Step 2: refer to the Enrollment Office in Padua – Via Venezia 13, on the day and time of the appointment with the application form, two photocopies of the identity document (the data entered in the enrollment application must be the same with those in the identity document), two identical passport-size pictures and the original receipt of the first installment of tuition fees.
