Having regard to Allegato B D.G.R. n. 1267 dated 08-08-2017 that states that the action is focused to attract professors and researchers coming from abroad awarding them visiting scholars fellowships in order to create an international research group and having regard to par. 4 of Art. 79 of the University's "Regolamento di Ateneo per l'amministrazione, la finanza e la contabilità" (Regulations Governing Administration, Finance, and Accounting) and "Regolamento delle borse per lo svolgimento di attività di ricerca", (Regulations Governing Research Fellowships), a selection announcement has been published for the awarding of no. 1 research visiting young fellowship at the Department of Economics and Management "Marco Fanno" under the supervision of Professor Giacomo Boesso, Research Project Supervisor. The research visiting young fellowship shall last for 3 months.

The research fellowship shall be for a total amount of € 12.000,00 (twelve

thousand/00) gross amount financed by "Nuovi modelli di business e valutazione dell'impatto sociale in percorsi di sensibilità per le PM" Project code 4285-1-1267-2017and will be paid in two different instalments, half at the beginning and the other half at the end of the research activities.

The visiting young fellow must carry out the following research activity:

- Designing an on-line survey targeting non-profit organizations, SMEs and B-Corp (one month)
- 2. Analysing the data (one month)
- 3. Crafting a co-authored working paper and submission to an international peer reviewed journal (one month)

The activities has to be fulfilled in strong interaction with local professors and with the active support of project-dedicated graduate students. As part of the project funded by Veneto Region ("NS2 nuove sfide e nuovi servizi", DGR nr. 1267 August 8th, 2017), The Department is going to conduct a survey to identify the positive interactions and capacity building relationships that occur when philanthropic or ethical capital (grants, equity or debts) is injected in SMEs or non-profit organizations. The project aims at defining and measuring the positive impact of social financing on the social impact of funded organizations, learning from national and international best-practices.

The visiting young fellow has to spend three months at the University of Padua, Department of Economics and Management and during this period will have the chance to engage with the different research activities hosted at the Department. The three-month period, even non-continuous, will be defined with Professor Giacomo Boesso, Research Project Supervisor, considering for research needs and project requirements. Travel expenses and any other related costs are not going to be refunded.

Admission requirements:

o Ph. D. degree

The elegibility of qualifications awarded abroad will be verified by the Selection Committee.

Required skills:

The visiting young research fellow:

- Has to be specialized in the study of social innovation, B-corps, business model for

sustainability and the like;

- Has to be based in a University/Research institution located abroad (not Italy);
- Has to have achieved her Ph.D. since no more than 7 years;
- Has to be available to spend three months even non-continuous at the University of Padua – Department of Economics and Management within the period July 2018 – May 23th 2019;

Incompatibility

The fellowships within this announcement may not be combined with:

- other research grants;
- fellowships of any other kind, with the exception of those awarded by national or foreign institutes to integrate, with periods abroad, the specific research activities required by this announcement.

In the case of self-employed, employed or parasubordinate employed, compatibility shall be determined by the Research Project Supervisor.

Research Fellowship Holder may not have marriage, family or kinship relationships up to the fourth degree with lecturers or researchers working at the Department elected as "Research Base", or with Rector, or Director General, or a member of the University Board of Governors.

The application must include:

- a) A dated and signed Europass CV with publications;
- b) a photocopy of a valid identity document (Identity Card or Passport);
- a cover letter suggesting potential contribution to the project based on ongoing research activities
- d) any other document, qualification or publication useful for the selection process.

Selection procedure

Candidates' applications shall be evaluated by a Selection Committee that will be nominated in accordance with the "Regulations Governing Research Fellowships," on the basis of their qualifications.

Prior to assessing candidates, the Selection Committee shall establish the maximum score, criteria and the procedure to be used in evaluating qualifications.

At the end of the selection process, the Selection Committee shall send the report to the Head of the Department for approval.

After verifying the legality of the deeds, the Head of Department shall approve by decree the ranking order and the awarding of the research fellowship.

The administrative office of the Department that issued the selection announcement shall notify the successful candidate.

The winner must accept the award within ten days of notification. Otherwise the winner shall forfeit the right to the research fellowship. In case of renunciation, the fellowship will be awarded to the next eligible candidate, according to the ranking order.
